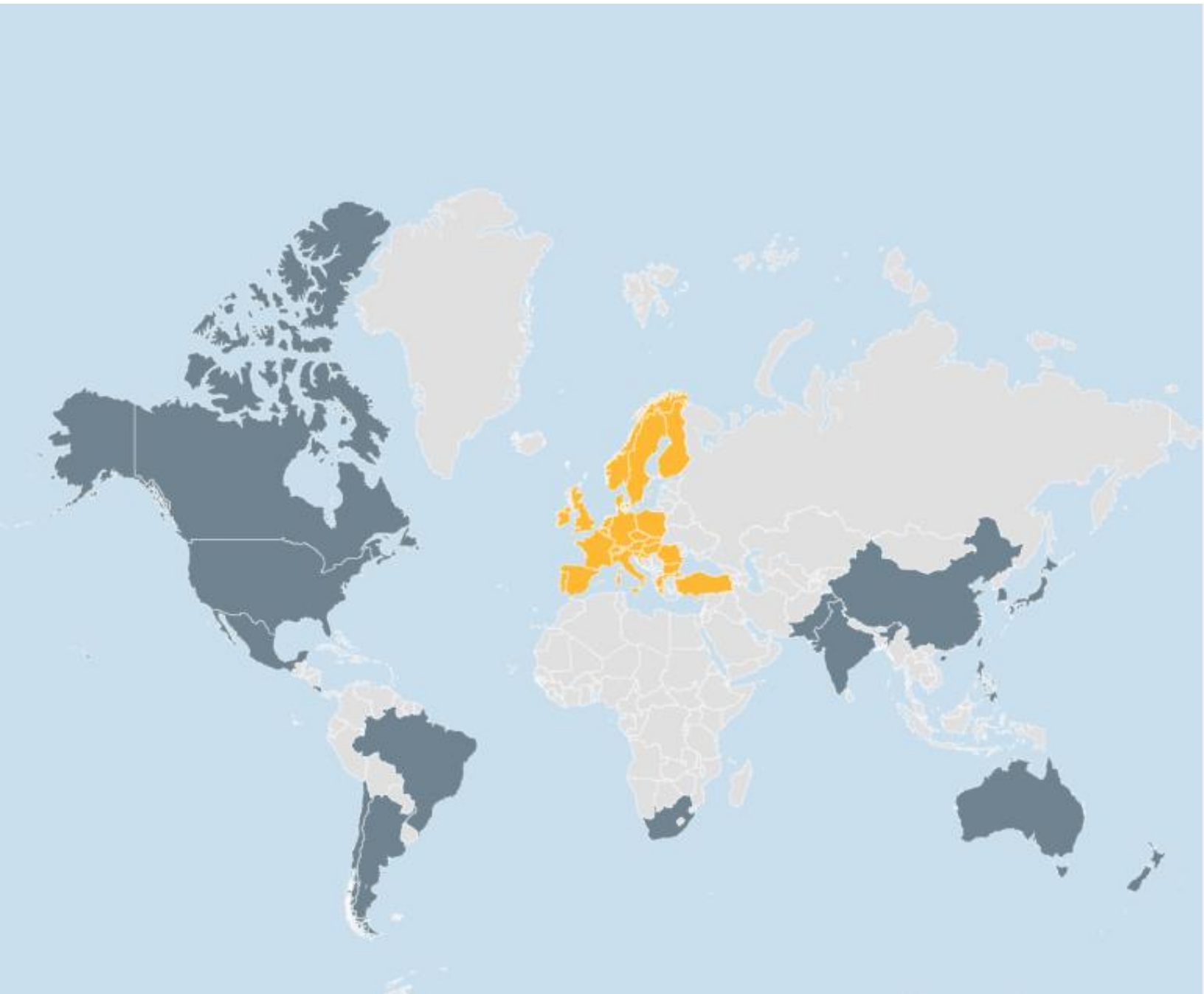


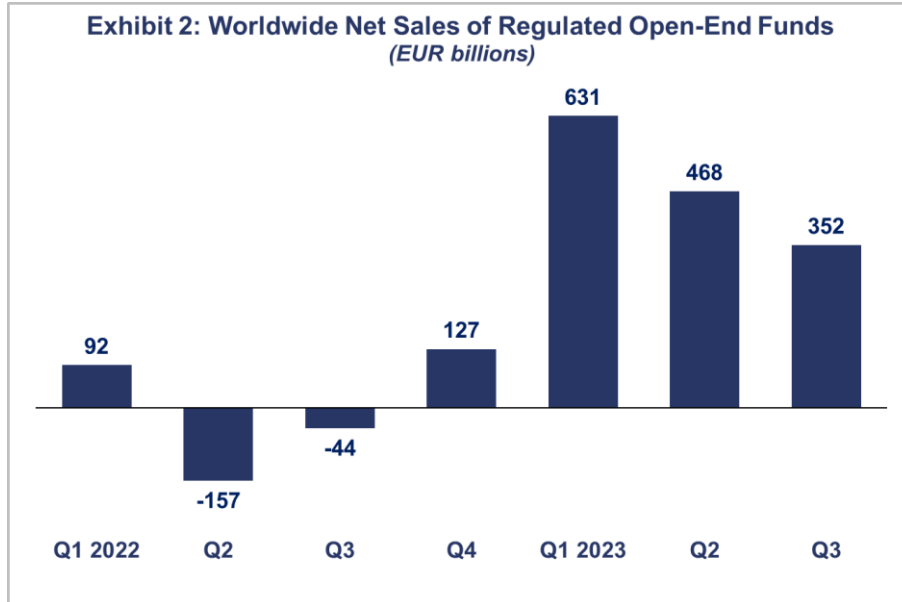
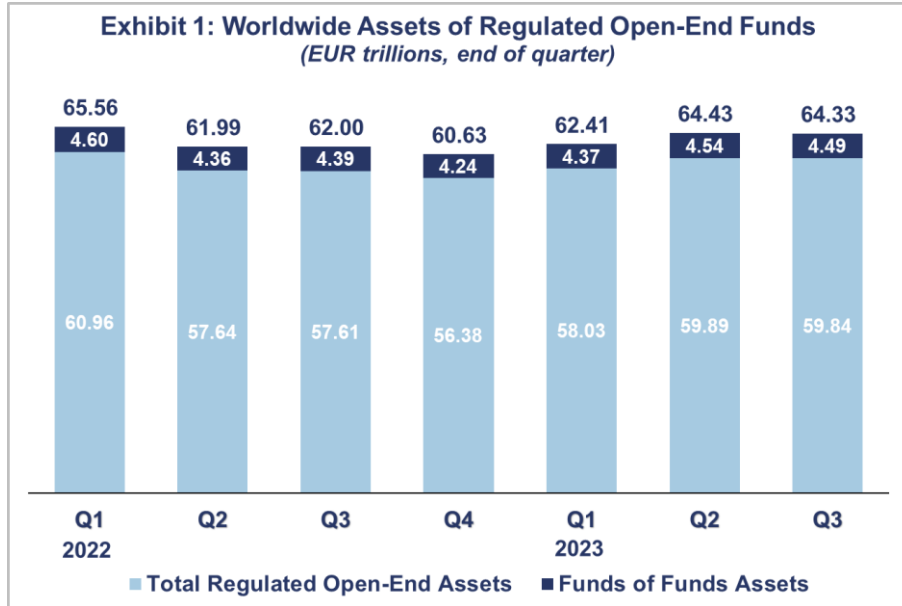
Worldwide Regulated Open-End Fund Assets and Flows

Trends in the Third Quarter of 2023



Brussels, January 9, 2024

Worldwide regulated open-end fund assets decreased by 0.2% in euro terms to EUR 64.33 trillion in Q3 2023.¹ Worldwide investment funds registered net inflows of EUR 352 billion, down from EUR 468 billion in Q2 2023.



¹ The information presented in this report was compiled by EFAMA and the Investment Company Institute (ICI) on behalf of the International Investment Funds Association (IIFA), the organization of national investment fund associations. Statistics from 46 countries are included in this report. All data presented in this report include funds of funds, exchange-traded funds and institutional funds.

Worldwide investment fund net assets measured in U.S. dollars decreased to USD 68.1 trillion at the end of Q3 2023; a 2.7% decrease from the previous quarter. The following two graphs compare the net asset growth in the seven largest countries/regions.

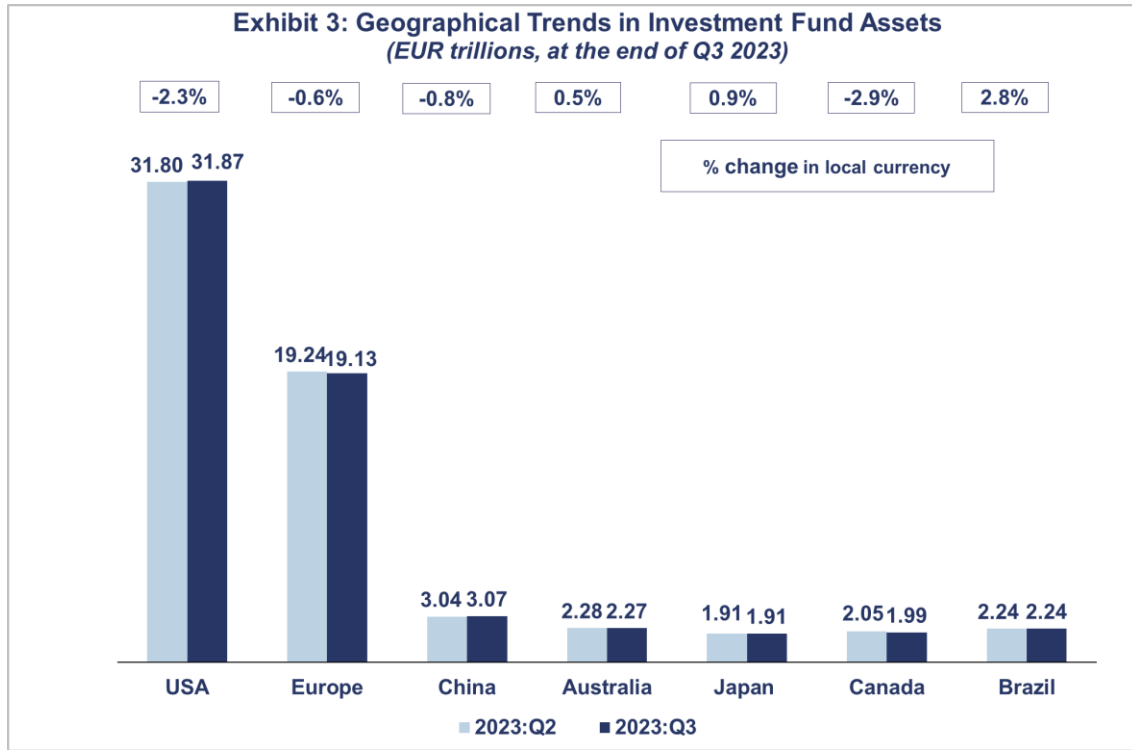

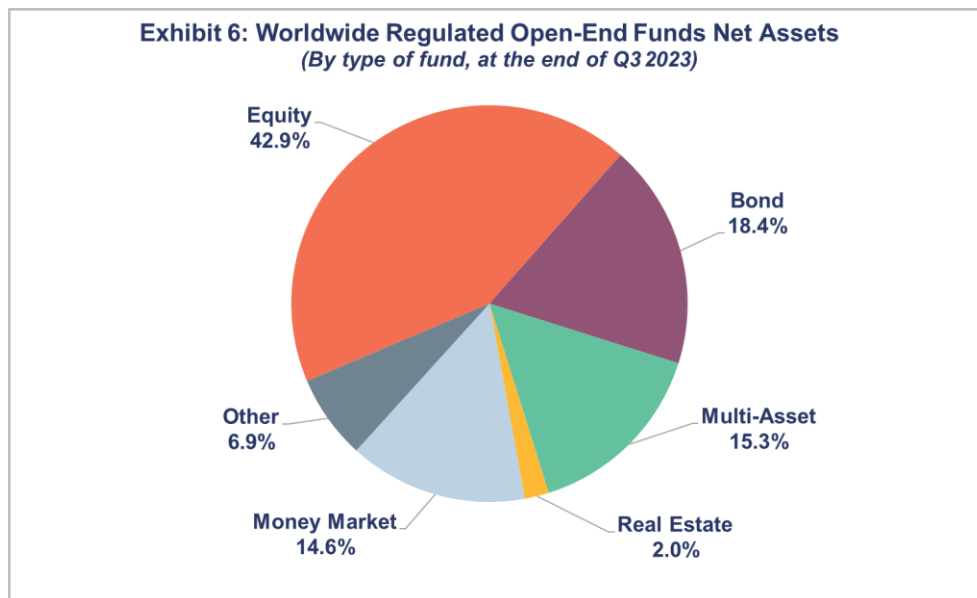
On a euro-denominated basis, global equity fund assets decreased by 1.3%, to EUR 27.6 trillion at the end of Q3 2023. Bond fund assets registered a 0.6% growth, reaching EUR 11.8 trillion. Multi-asset funds experienced a 2.6% decline, dropping to EUR 9.8 trillion, and money market funds (MMFs) increased by 5% to EUR 9.4 trillion.

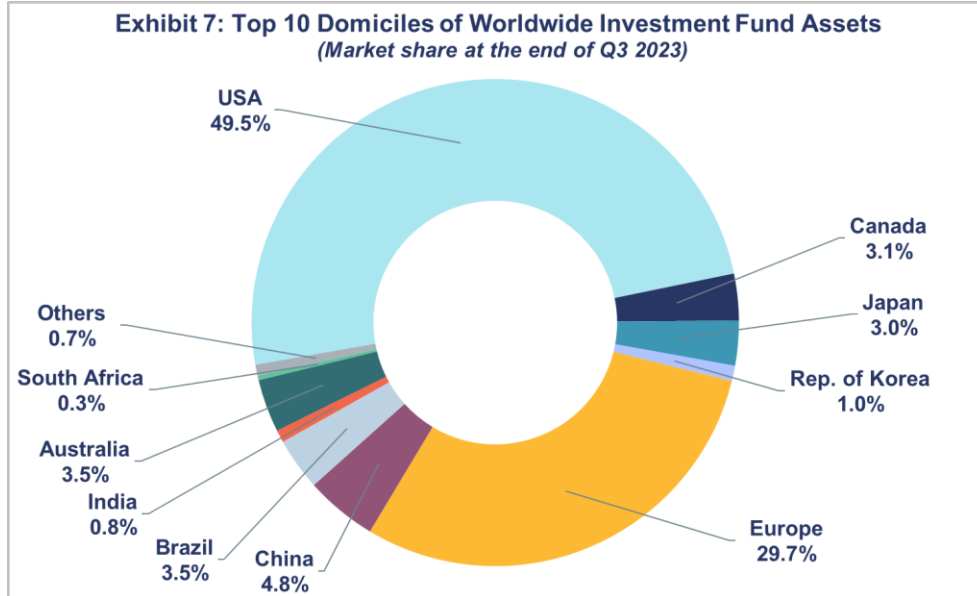

At the end of Q3 2023, 42.9% of worldwide regulated open-end fund net assets were held in equity funds. The share of bond funds amounted to 18.4% and the asset share of multi-asset funds was 15.3%. MMF assets represented 14.6% of the worldwide total.

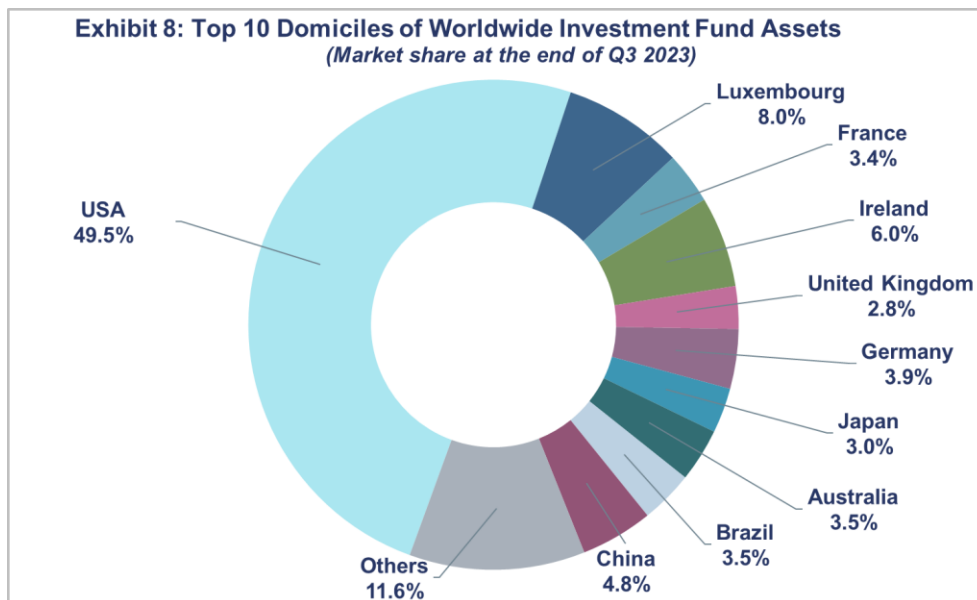

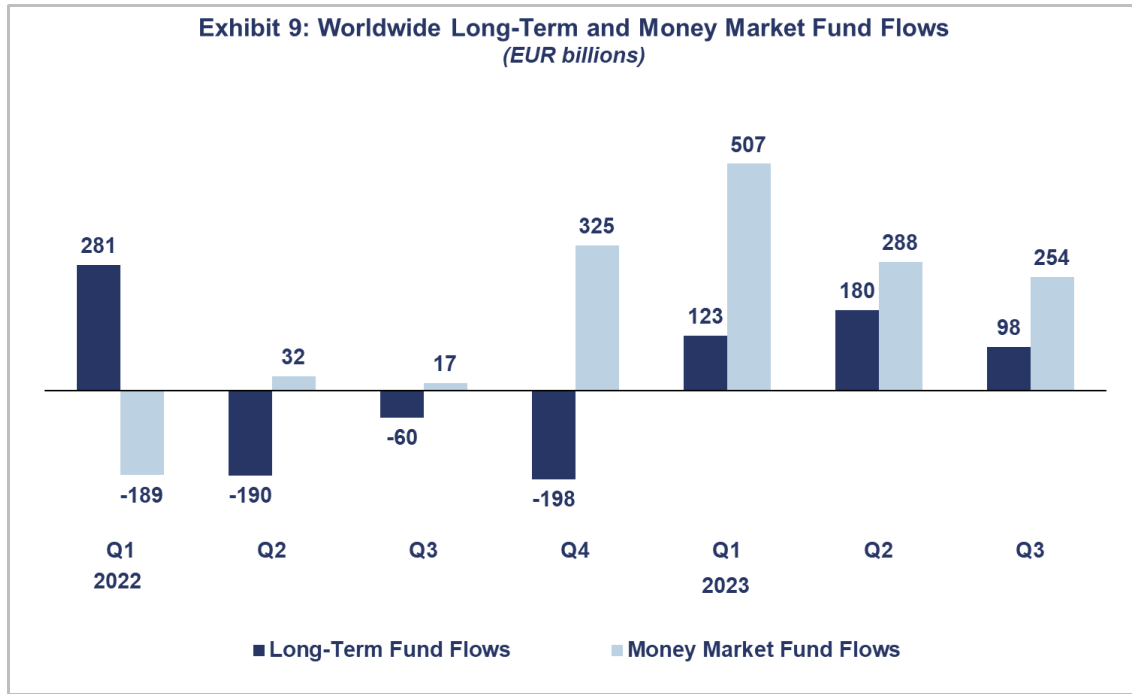
Looking at the worldwide distribution of investment fund net assets at the end of Q3 2023, the United States held the largest share in the world market, with 49.5%. Europe followed in second place with a market share of 29.7%. China (4.8%), Australia (3.5%), Brazil (3.5%), Canada (3.1%), Japan (3%), Republic of Korea (1%), India (0.8%), and South Africa (0.3%) follow in this ranking.



Overall, five European countries ranked among the top ten largest fund domiciles in the world: Luxembourg (with 8% of worldwide investment fund assets), Ireland (6%), Germany (3.9%), France (3.4%), and the United Kingdom (2.8%).



Worldwide regulated open-end funds registered net inflows of EUR 352 billion, down from EUR 468 billion in Q2 2023. Long-term funds recorded net sales of EUR 98 billion, compared to EUR 180 billion in Q2 2023. Net sales of MMFs amounted to EUR 254 billion, down from EUR 288 billion in Q2 2023.



Globally, equity funds recorded net inflows of EUR 59 billion, compared to net outflows of EUR 30 billion in Q2 2023. Bond funds saw net inflows of EUR 98 billion, a decline compared to EUR 209 billion in the previous quarter. Multi-asset funds continued to experience net outflows (EUR 85 billion), marking the sixth consecutive quarter of negative net sales.

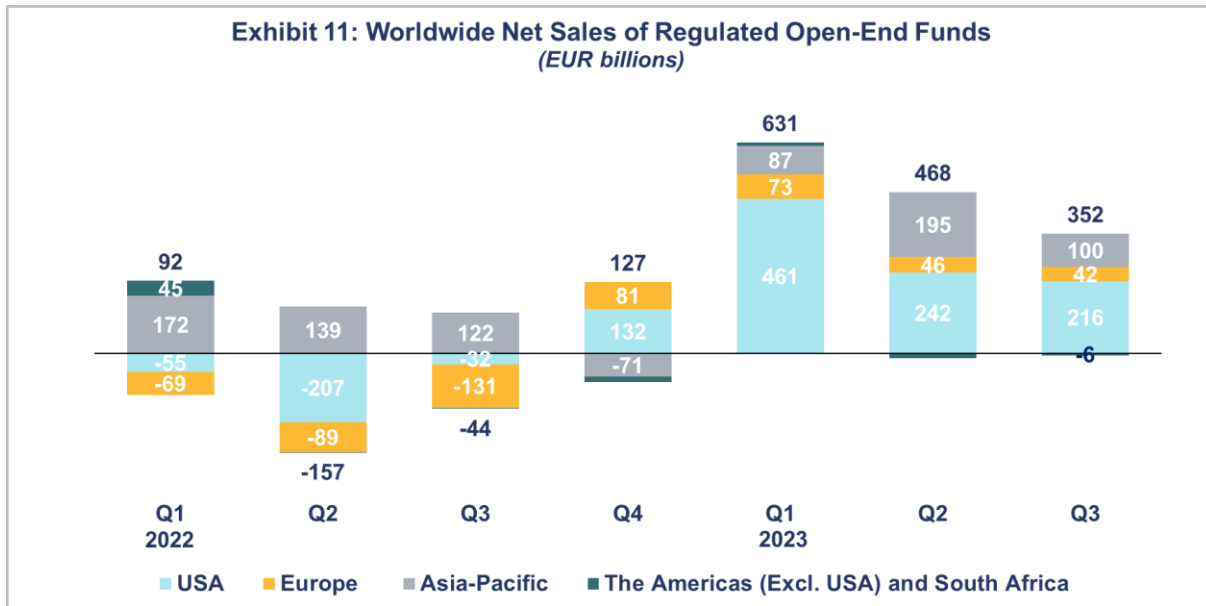

During Q3 2023, the United States registered net inflows of EUR 216 billion, a decrease from EUR 242 billion in Q2 2023.

The Asia-Pacific region² saw net inflows of EUR 100 billion, compared to EUR 195 billion in Q2 2023. Net sales were primarily driven by equity funds (EUR 81 billion), mainly in Japan and China which recorded EUR 37 billion each. Overall, Japan’s regulated open-end funds recorded net sales of EUR 38 billion, followed by China (EUR 21 billion) and Korea (EUR 15 billion).

Europe experienced net inflows of EUR 42 billion, mainly thanks to positive net sales in Ireland (EUR 50 billion) and Germany (EUR 15 billion). On the other hand, Luxembourg registered net outflows (EUR 34 billion), as did the UK (EUR 7 billion).

The Americas³ were the only region to report negative net sales in Q3 2023, with net outflows amounting to EUR 6 billion, compared to net outflows of EUR 14 billion in Q2 2023. Brazil and Canada recorded net outflows of EUR 15 billion and EUR 7 billion, respectively. On the other hand, Argentina and Mexico both registered net inflows of EUR 5 billion.



European long-term funds saw an overall decline in net inflows, dropping from EUR 37 billion in Q2 2023 to EUR 3 billion. Equity funds recorded net outflows of EUR 2 billion, compared to net outflows of EUR 31 billion in Q2 2023. Multi-asset funds continued their trend of net outflows, EUR 15 billion compared to EUR 4 billion in Q2 2023.

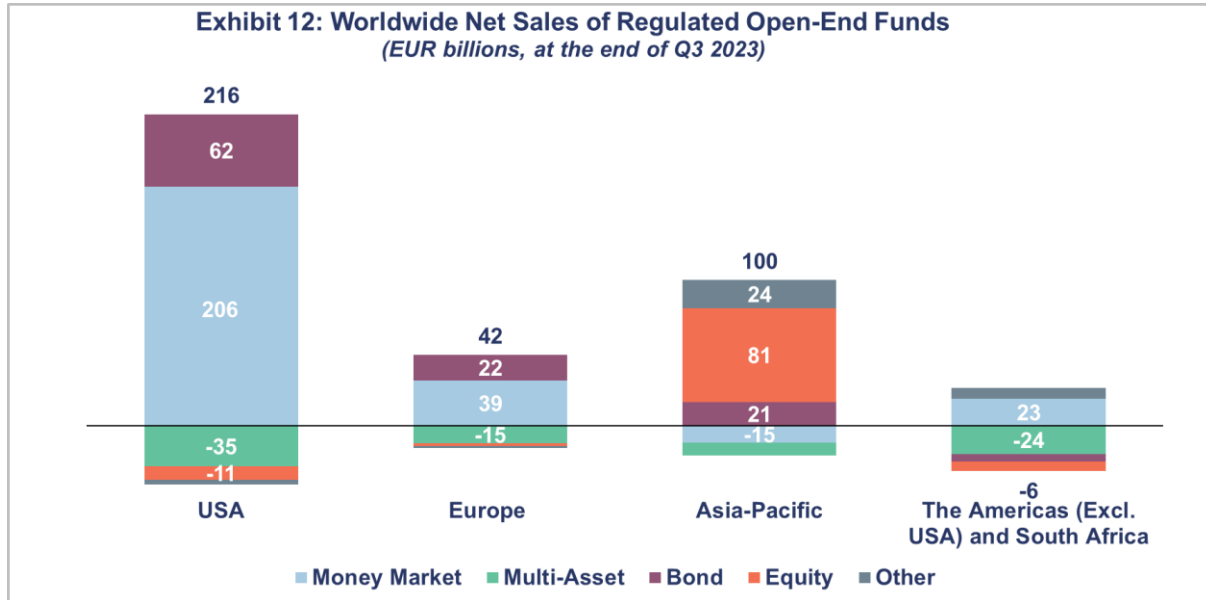
On the other hand, net sales of bond funds remained positive at EUR 22 billion, albeit lower than the EUR 44 billion recorded in Q2 2023. MMFs continued to experience net inflows of EUR 39 billion in Q3 2023, up from EUR 9 billion in Q2 2023.

In the United States, long-term open-end funds registered net inflows of EUR 10 billion, compared to EUR 59 billion in Q2 2023. This shift was influenced by a decline in the net inflows into bond funds, which declined from EUR 88 billion in Q2 2023 to EUR 62 billion. Multi-asset funds continued to record net outflows, EUR 14 billion in Q2 2023 and EUR 35 billion in Q3 2023. Net outflows of equity funds also continued over the quarter (EUR 11 billion, compared to EUR 15 billion in Q2 2023).

MMFs in the United States attracted strong net inflows of EUR 206 billion, up from EUR 183 billion in Q2 2023.
